Noted by his peers for his tireless mentoring, and his work improving techniques for production, management, shearing, fencing, pasturing, and wool handling, he truly merits his

In presenting it, colleague Isaac Matchett said, "As a shearer he not only trained myself and others but also took us on his jobs, provided equipment when needed, provided transportation to contests and exposure to the shearing industry. As a producer, in traveling with Jim, we had the opportunity to see and explore many of the great sheep farms in this state and meet many other producers. We gained a network of connections and got to share experiences and learn from one





Fifteen train cars of cattle biggest consignment in state history (April 29, 1954)

Some 644 "native" cattle of the plains of Eastern Colorado and the western Kansas are becoming acquainted with the lush green grass of the plains

The "natives" are many "short yearlings" steers that arrived at Standish after a long four-day train trip from Fort Dodge, Kan., and now are being fattened **SALLY REA** for the fall sale on the 6,500-acre Prescott Ranch, in Prescott, Mich.

of Ogemaw County.

These cattle are valued at approximately \$65,000 when they arrived at Standish, Mich. The15-car train is believed to be the largest single shipment of livestock ever delivered into Michigan. It wasn't cheap for

> the shipping of the cattle. It was approximately \$4,000 plus another \$225 was spent for the feed for the cattle for their journey.

The cattle left Fort Dodge, Kan., Saturday around noon. Under livestock shipping regulations, the cattle

could not be left for more than 36 hours in the train cars. The steers were unloaded, watered and fed at Fort Madison, Iowa, and again at Calumet City, Ill. The cattle were

averaging 500 pounds in weight when they were shipped, and they will probably gain a few pounds in their shipment.

Awaiting their arrival of the trainload of steers at Standish, were two large tractors and semi-trailers provided by Lughill Bros., Archbold O., livestock commission brokers and packers, who took care of the transaction. These trailers were capable of hauling 45 of the 500-pound steers. A smaller trailer and two stake trucks provided by the Prescott Ranch, completed the unloading and transporting of the cattle to the ranch, a distance of 25 miles. Wednesday the herd was treated by the veterinary at once.

It was mentioned that they had to make this a business if they are going to come out on top.

"By carrying on our ranching and stock raising in this manner we are only proving my contention that the future of Northeastern Michigan, as far as agriculture is concerned, lies in full utilization of cutover grazing land," Senator Prescott stated.

Feeder cattle received at the Prescott Ranch this spring will be ready for the market by Sept.15 and they will all be sold by Oct. 15. They will have gained approximately 50 percent in weight, making 750 pounds. This gain is entirely from grass, no grain being fed. Many of the animals go to herds in southern Michigan counties, such as Lenawee, Hillsdale and Monroe, where they are fattened for the market. Last year (1953) one Monroe stock farm took 400





there's a lot of people who don't necessarily understand technology in their hand. If we're able to help, if we can't fix it for them on the spot and get them pointed in the right direction, then we did our job.'

Weiss stressed that "customer service is the number one priority." A look at Facebook reviews for the West Branch AT&T outlet shows overwhelming satisfaction with the service customers received since the store opened last October.

When customers become frustrated or impatient with their phone, his studies in psychology come in handy. "I like understanding people and I like understanding basically how to come to a place where people can just show each other a good amount of respect and understand each other — and have empathy."

Along with empathy, Weiss matches the best phone for each customer. "The biggest difference between me and most other training managers is I only want our sales people to build a package that makes sense for the customer. We want our customers to be happy and come back, which means, at the end of the day, we're going to build a package that just makes sense for their needs and what they'll actually use."

One feature of AT&T's service in Ogemaw County is its coverage of rural areas and subsequent data speeds.

"I'm able to show a network speed test. Customers with a rival company's phone "might

get lucky to get 15 megabits per second on their network speed, whereas we can push 65.

As for coverage, he said, "I've tested out all the phone carriers myself. I noticed there are some spots where a (competitor) does better, but the majority of the time AT&T works better. A prime example would be the Ogemaw County fairgrounds. I noticed that AT&T has significantly better service there."

Aside from customer service, Weiss is planning for future growth of the AT&T brand in the West Branch area. The age of his customers is skewing toward younger customers.

He observed that the "West Branch demographic is actually changing slowly. It's becoming more young families who are here. So being able to target the youth, growing up, getting ready to get their own plan, being able to show our support in the community, showing that we're a business with family values, that's big."

One strategy for reaching out to a younger demographic is sponsoring the Dragon Dead Productions' Super Shogun Wrestling event held at the West Branch Outlet, Weiss said, "It's a family event, so kids are out there loving it and us helping to support them while we did. It's something nice for the kids to be able to go enjoy."


