#### Prayers for 'Mighty' Malikai:

### WB family prepares for the worst - praying for a miracle for son with terminal cancer

Malikai Petty, a second grader at Surline Elementary School, is suffering from a rare, aggressive form of cancer and has only been given a few weeks to months to live. He and his family need the community's support now more than ever, both emotionally and financially.

A West Branch family is preparing themselves for the unimaginable loss of their young son, Malikai (Kai) Petty, who has been heroically battling cancer for well over a year.

Tragically, he has only been given a few weeks or months to live by his medical team. Family and friends have rallied around Kai and his parents, Travis and

Sara, and his older brother and sister, Jax and Kadence, to offer emotional support, as well as monetary donations for his quality of life of the time he has left and for his final expenses.

"Why our baby?" Sara wrote as she shared the news with friends and family in a post on Facebook. "Why did last month we have hope, and now there is no longer hope? How is this all happening

so fast? Our hearts are completely shattered..."

In an interview with the Ogemaw County Superior News, she described Kai as the "sweetest boy in the world."

"He is kind, sweet and funny...," she said, admitting that it is hard just to get out of bed these days. "The reason I get up is for my kids. They are my whole world...I have to be strong for



# Ogemaw Heights High School presents 'Letters to Sala'

The Ogemaw Heights Theatrical Troupe is very excited to present to you "Letters to Sala", by Arlene Hutton, on Nov. 6 to 8. "Letters to Sala" is a true story about a woman named Sala Garncarz who survived Jewish persecution in World War II and hid over 350 letters and photos which document her's and many others' experiences during the Holocaust.

Sala went to a labor camp in place of her sister, Raizel, on Oct. 20, 1940, when she was just 16 years old. Through the course of the war, she was an inmate at seven different Nazi labor camps until liberation, when she was 21. Sala saved her letters and told no one about them until, in 2005, when she gave them to her daughter, Ann (played by Sadie Syerson), before she underwent cardiac surgery.

The play depicts the young Sala collecting the letters as a teen, as well as the conflict that Ann faces while deciding what to do with Sala's diary, letters, and postcards written by over 80 different people.

This fall's play at OHHS is quite different from what we have been presenting the past few years. Due to the ongoing construction and renovation of the auditorium, we needed to choose a show that was flexible in staging and rehearsal demands - and "Letters to Sala" has been a perfect fit for our needs, as well as giving actors the opportunity to focus on developing as character actors and

portraying more serious roles.

In "Letters to Sala" two stories play out at the same time on different sides of the stage; one is based in Sosnowiec, Poland, in the 1940s. In this, we follow young Sala's (Olivia Cummings) perspective through the labor camps as she receives her letters. Meanwhile, the other story follows older Sala (Skylar Smith) and her family based in New

York, in 2005. The staging has another key element: every single real letter was scanned and placed online, and during the show, images of these letters will be projected as well as the photos of the true people the actors have the honor of portraying on the stage.

In addition to the gripping narrative, it is also exciting to be the first performance in the renovated auditorium space, which includes new seating, updated carpets, fresh lights, and a state-of-the-art sound booth, as well as new stage flooring. This renovation has opened up so many more opportunities for our Ogemaw Heights Theatrical Troupe to flourish, not only now, but also in the future.

With direction by Toni Thomas, sound from Tom Rea, and help from Mark Andersen, our Theatrical Troupe promises that this

# Nominations sought for 'Wall of Honor'

The Ogemaw County Wall of Honor was first established in 2019 to permanently honor individuals who have been instrumental in county government and/or performed volunteer services deemed to have been of great importance to the improvement of the county.

Commissioner Craig Scott was one of the board members when the wall was first established. He said, "This wall serves as a place for people to learn about our local history and honor the heritage and journey of many of our local families."

Currently there are six persons who have been immortalized on the wall: Clarice Sperry, Adrian Dantzer, Miriam Rosebrugh "Gramma Red", Harold "Bud" Smith, Jr., Scott Colclasure, and Dr. Robert Rea. The induction ceremony occurs at a public board meeting where friends and family have an opportunity to speak about the inductee's life accomplishes and share fond memories.

To have a person selected for the Wall of Honor, each recipient must be nominated by an Ogemaw County resident and be chosen by a majority vote of the Ogemaw County Board of Commissioners. If selected, the honoree will have a plaque dedicated to them with their picture and biography displayed.

The qualifying criteria for

nominees are:

Nominee has had a significant impact on the continuation and/or enhancement of the county.

Nominee was a pioneer in his or her field of service.

Nominee's quality and length of service.

Nominee must be deceased.

Currently, the OCBC are accepting new nominations for the wall of honor. All sponsors must fill out an application and have it submitted by April 1 each year. If their nominee is selected, the sponsor is required to pay \$150 for the cost of the plaque. All nominations are reviewed by the Committee of the Whole by April 30 each year. If you know of an individual deserving of this tribute, applications can be picked up at the Ogemaw County Prosecutor's Office during normal business hours or you can go to the county's website at www.ocmi.us under the prosecuting attorney's tab and fill out an application online.

By choosing to nominate a person for whom you had great respect and admiration, you are insuring that while they may be gone from this earth, they will never be forgotten. And also, by sharing their life example, you can inspire future generations to be selfless and productive citi-



# Giving hope to children through foster care

Foster care is a beautiful tapestry woven with stories of hope, love and resilience. It's one of the most compassionate and selfless actions a person can undertake, as it offers a lifeline to children who have faced unimaginable challenges.

For as long as I could remember, even in the midst of my own dysfunctional upbringing, I've wanted to be a foster parent. As a seven-year-old girl, I knew that I wanted to give love, hope and safety to those who longed for it. I might not have known those exact words, but I knew that I wanted to give someone the gift of safety and belonging. I wanted to be a voice to those whose voices went unheard. That longing stayed buried in the deepest parts of my being for many years.

Shortly after my husband and I were married, I discovered that a little girl I had known from church would be leaving her foster home once school ended for the summer. This grieved my heart to know that she would be moving to yet another home to again start over, all while reunification efforts were still underway. She had only been in care for a little over a year; she would be moving to her second home.

There was also one more thing I knew these children needed, and I could offer. Stability. I wanted to give them the ability to unpack. Unpack their hopes, dreams, and feelings without wondering if they would once again be moved.

I knew from an early age how difficult it was to properly form attachments when a child has to continually start over. Starting over was never easy for anyone, let alone children in these situa-

I had spoken to my husband about this little girl and suggested we apply for our foster license. He wasn't quite as eager as I was. There were a lot of questions, fears, and sacrifices. The journey of foster parenting is not just about providing a roof over a child's head; it's about opening your heart to nurture, guide and love a young person who needs

it the most. This was terrifying to him, but he agreed to think about it. Think about it, he did. In fact, he wrestled with it. It kept him awake, wondering, praying.

Three days later, like Jonah in the belly of the whale, he said,

We both recognized the need for foster care, and we acknowledged the sacrifices we would be making.

We chose to embark on this journey while understanding that these kids didn't make this choice.

We embarked on the path with grace and compassion.

What's next, he asked.

The first thing we had to do was contact an agency to begin the application process. While there are several options to choose to apply with, we chose DHHS. There are also private non-profit agencies, however.

We asked our questions, and from there we were assigned a

licensing worker. Our worker asked us at least a 1,000 questions before we even got our applica-

Next was our home study. This was a bit of a lengthier process. It required us to answer detailed questions, obtain physbackground checks, fingerprinting, and a home inspec-

The final step was a two-day training called GROW. This is


where we learn how to navigate the world that we will be stepping into. We would learn how to build relationships and communicate with the kids who would be in our

After this, our application, home study, and recommendations were then sent to the state for their approval. This can be a lengthy process, averaging approximately four to six months.

Being a foster parent is one

of my greatest joys. As children learn to trust and let you into their world, we have the privilege of watching them grow, heal and

bloom.



communities throughout the state, to turn underutilized, blighted properties into assets that can be used to serve residents, support small businesses, and, frankly, attract both tourists and new talent alike. And this is a great example of that. We know that people, places, and projects are instrumental in driving economic prosperity throughout the state, and I want to congratulate all the partners that were involved in making this vision a reality. A one-year timeline, I can say, is pretty impressive."

"We could not have done that without the contractors: Three Rivers, Finish Concrete, Ace Electric, and Michigan with the parking lot," Hickmott said.

To give those gathered a view to what it took to achieve so much in so little time, Justin Benjamin from Finish Concrete said, "Here on Oct. 14, with the warm weather, this didn't start this way when we broke ground last November and into April and March. 



In the spring of 2004, Kai's parents noticed he was limping and was having a hard time bending over. Doctors believed it was just a pinched nerve and referred him for physical therapy, but he just got worse.

An MRI was ordered, and it was determined that he had some form of cancer, but it wasn't clear of what type they were dealing with.

"He was in the hospital in Grand Rapids for a month, but they didn't know what type of cancer he had," Sara said. "Initially, they thought it was leukemia."

After further testing, he was

ultimately diagnosed with Stage 4 alveolar rhabdomyosarcoma (ARMS), which is a rare and aggressive type of soft tissue cancer that primarily affects children and young adults. It originates in the skeletal muscle cells and ARMS often occurs in the extremities, trunk, and head and neck regions, and can spread to other parts of the body.

Kai underwent chemotherapy once a week for a year at De-Vos Children's Hospital in Grand Rapids.

"Emotionally, he didn't do well," Sara said, adding as they neared the hospital anxiety would take control. "He would throw

up...the anxiety was that bad."

Just last month, on Sept. 4, after some regular routine scans, the family was overjoyed to learn that there were no more signs of cancer in Kai's body.

For the first time in over a year, he went back to school at Surline Elementary School, and all was well in the Petty family's world.

Then it all came crashing down, again. After only a few weeks in school, Kai's second grade teacher, Elizabeth Moore, noticed that Kai was limping. She notified his parents right away and another MRI was ordered.

"They found a tumor behind his right kneecap," Sara said. "There is no cure, and he had only a few weeks to months to live."

On Friday, Oct. 17, the family traveled to Grand Rapids one last time. It would be determined how long Kai had left by running a PET scan to determine if the cancer spread to his organs.

On Monday, Oct. 20, Sara announced on Facebook that it indeed had.

"It is in his lungs, sternum, pelvis, spine, hips, legs and bone marrow," she wrote. "They have put the referral into hospice care, and they will be here tomorrow to do an assessment and get to know Kai and our family.

"We agreed to get hospice on board sooner rather than later, so we have another avenue of support for Malikai," she added. "They are local and will come to our home, so no more driving across the state for appointments. We are all still just trying to process this, as it's all happening so fast. And seems so surreal. We are enjoying our time together as a family, but our door is also open for healthy visitors. Again, just want to thank everyone for the love and support."

Before the latest news, the family had made the heart wrenching decision to not continue Kai's treatment any longer.

"There are some clinical trials." Sara said. "But the chances are slim to none that it will work, and the side effects would outweigh the benefits.

"We've decided not to prolong

The family is bracing themselves for the inevitable and recently visited the funeral home to plan Kai's final arrangements, which will cost about \$7,500.

To make matters worse, if possible, Travis, who Sara said is "struggling silently," hurt his back at work recently and has been off

"It's just been a lot," Sara said. 'We've drained our accounts.

"The community has just been amazing," she added. "We are so grateful for the support system outside of our immediate family."

The family's pain is unimaginable, and the last thing they need to worry about is finances in their darkest hour.

# MyMichigan offers lung cancer screenings

In recognition of National Lung Cancer Screening Day, MyMichigan Medical Centers in Alma, Alpena, Midland, Saginaw, Tawas and West Branch are offering lung cancer screenings on Saturday, Nov. 8, from 9 a.m. to noon. The main purpose of National Lung Cancer Screening Day is to rise above the stigma and celebrate individuals who make the decision to get screened for lung cancer regardless of their smoking history or current smoking status.

By extending hours, we are increasing access for this life saving screening to allow individuals to be screened without taking time off work during the week," said James Fenton, M.D., board-certified, fellowship-trained thoracic surgeon, MyMichigan Health. "A low dose CT is the single most effective strategy for reducing mortality from lung cancer."

Lung cancer is one of the deadliest forms of cancer and is estimated to claim the lives of more than 127,000 Americans this year. Even though survival rates can be improved significantly by screening, only a small percentage of eligible individuals get screened for lung cancer.

"A lung cancer screening is for those who smoke, or have smoked in the past 15 years, but currently don't have symptoms such as pain, a persistent cough or an unexplained weight loss," added Dr. Fenton. "This screening is designed to find lung cancer at an early stage when more successful treatments can be offered. Without a screening, most lung cancers are typically discovered at a late stage."

Those eligible and who could

benefit from lung cancer screening include those age 50 to 80 years old and currently a smoker or have quit within the past 15 years. Also, those who have been exposed to cigarettes that add up to 20 pack years. For example, someone who smoked at least 10 cigarettes per day for 40 years or one pack for 20 years or two packs for 10 years. In addition, those who have met all the requirements and have no acute symptoms or have not had a CT low dose lung screening within the past year are a good candi-

## Collaboration focuses on maternal and infant care coaching, education

MyMichigan Medical Center Tawas, in collaboration with District Health Department (DHD) #2, recently piloted "Maternal & Infant Care Coaching, Connections and Capacity," a grant-funded program supported by the Michigan Health Endowment Fund. This innovative initiative connects community health workers, nurse navigators, providers, and DHD No. 2 staff to support women and children from pregnancy through a child's first 18 months.


The program created a simplified referral system to help families access a wide range of DHD No. 2 services. These include support for basic needs such as housing, transportation, and food insecurity, as well as resources to address other social determinants of health. Families also benefit from prenatal classes, educational materials, and hands-on opportunities for both parents. Fathers, for example, can learn skills such as swaddling, holding, and bathing a baby while forming connections with other local dads.

"We are thrilled with the success of this program. MyMichigan Health and DHD No. 2 are committed to continuing this important community education and referral network for local families beyond what was established with the initial grant," said Alissa Parnicky, former registered nurse navigator for the program. "Parents can take part in eight educational classes—offered virtually or in person, individually or in groups-that help build confidence in caring for newborns and infants in a safe, supportive environment.'

Since launching, the program has led to increased enrollment and referrals for several health and family services, including Michigan's Women, Infants and Children Program (WIC), Maternal Infant Health Program (MIHP), the Breastfeeding Peer Counselor Program, Healthy Futures, Healthy Families, Community Connections, and Immuniza-

By identifying needs early, the program promotes healthy pregnancies and helps ensure that families have access to nutritious food, reliable transportation, prenatal care, safe sleep education, and ongoing support to make informed decisions.
